Regulations relating to Examinations for the semester wise Four-Year B.A./B.Sc./B.Com. (Honors with a core vocational subject under CCF, 2022) Courses of Studies conducted by the University of Calcutta

- 1) The 4-year B.A. / B.Sc./ B.Com. (Honours with a Core Vocational subject) Course of Studies under CCF, 2022 shall consist of Eight (8) Semesters (Semester-I, Semester-II, Semester-III, Semester-IV, Semester-V and Seinester-VI, Semester-VII, Semester-VIII) with exit options after 2nd, 4th & 6th Semester s.
- Semester End Examinations are to be held ordinarily at the end of the 2) concerned Semester, i.e., Semester-II, Semester-III, Semester-V, Semester-VII in December-January and Semester-II, Semester-IV, Semester-VI, Semester-VIII in June-July.

3) Requisite Attendance:

- (i) A Student attending at least 75% of the total number of classes* held shall be allowed to appear at the concerned Semester End Examination subject to fulfilment of other conditions laid down in the regulations.
- (ii) A Student attending at least 60% but less than 75% of the total number of classes* held shall be allowed to appear at the concerned Semester End Examinations subject to the payment of prescribed condon tion fees and fulfilment of other conditions laid down in the regulations.
- (iii) A Student attending less than 60% of the total number of classes* held shall not be allowed to appear at the concerned Semester End Examinations.
- *Such attendance will be calculated from the date of commer cement of classes or the date of admission, whichever is later.

Calculation of attendance percentage shall include all the courses offered in the concerned semester.
